# Malta's Digital Nomad Visa

Applicants must prove they can work remotely, using telecoms. Applicants must also be third country nationals (non-EU, non-EEA, and non-Swiss nationals) and have a minimum gross yearly income of €42,000.

Eligible dependants, who can be included in the application are:

- the spouse
- minor children of the MA and/or spouse
- adult children of the MA and/or spouse, which children are not married and who are principally dependent on the MA
- adult children of the MA and/or spouse, which children are unable to cope independently due to a medical condition or disability may apply for a Permit under the same conditions, together with the MA.

In addition, applicants must prove they fall under any one of the following 3 categories:

- Employed with an employer registered in a foreign country and has a contract of employment.
- Self-Employed conduct business activity for a company that is registered in a foreign country and of which applicant is a partner/shareholder.
- Freelance offer freelance or consulting services to clients whose permanent establishments are in a foreign country, and with whom the applicant has contract agreements

# **Documentary Requirements:**

- Valid travel document;
- Valid property rental/purchase agreement covering the whole duration of the permit upon approval of application; and a
- Valid health insurance policy upon approval of application.

### Restrictions

A Nomad Residence Permit holder, including also his/her dependants cannot offer their services or be engaged in any economic activity with employers/companies based/registered in Malta. Third-country nationals offering services to companies registered and based in Malta would need to renounce their Nomad Residence Permit and apply for a residence permit on the basis of employment and/or self-employment in Malta.

In addition, the applicant must be:

- be fit-and-proper and of good conduct and do not pose any potential threat to national security, public policy, public health or public interest;
- be in possession of sufficient financial resources to support themselves and any dependants; and
- must not have had previous applications for permanent residency, residency-by-investment or citizenship rejected in Malta or abroad.

The Malta Startup Residence Programme is open to:

- startup founders and co-founders; and
- core employees who are vital for the startup to start operating in Malta and who have specialised skills;

• family members of the startup founders, co-founders and core employees, including, spouse, de-facto partner, minor children and adult sons or daughters who are principally dependent on the founder/core employee.

2. Founders co-founders and core employees must be 18 years and older.

3. Founders, co-founders, core employees and family members must be third-country nationals, non-EU, non-EEA and non-Swiss.

#### **Business eligibility**

•

1. A startup undertaking shall be considered eligible if it is, or shall be, engaged in one or more of the following activities in Malta:

- Manufacturing
   Software development
   Industrial services
   Health, biotechnology,

   analogous to manufacturing
   pharmaceuticals and life sciences
- Eco startups involved in the blue, green and sustainable industries
- Other innovative economic activities which are enabled through knowledge and technology providing services or products which are currently not readily available in the relevant market or which shall be provided through a process which is novel

2. The startup must have been registered for no longer than seven (7) years and not exist due to a merger.

3. Eligible business projects must meet at least two of the following criteria:

- I. propose products and/or services that have the potential to generate income from various geographical markets;
- II. produce products and/or services which are new, innovative or substantially improved compared to complementary products on the market;
- III. utilise processes which are new or substantially improved compared to those adopted in current complementary activities.

4. Share capital - the incorporated startup in Malta is required to place a tangible investment and/or paid-up share capital of not less than €25,000.

If there are more than four (4) co-founders apply for the Malta Startup Residence Programme, an additional €10,000 needs to be placed per additional co-founder. In any case, the maximum number of co-founders eligible for the Startup Residence Programme is six (6).

**5.** Permit Duration & Fees - the residence permit will be issued for an initial period of 3 years, which is renewable for a further 5 years (3 years for core employees) as long as the startup is still ongoing and the founder/co-founders still meet the programme's eligibility criteria.

# After 5 years residency, long term residency under European law may be applied for.

A cost competitive application fee of €750 per adult applies. A residency card fee of €82.50 also applies
